Facilities: Cross Country Course & Hacking Facility at Riding Farm Equestrian Centre.

- 1) Anyone using these facilities at Riding Farm Equestrian Centre **must** report to the Reception **Prior** to using them.
- 2) All use facilities at own risk. Anyone using facilities without prior authorisation will be asked to leave the site immediately.





- 3) The staff of Riding Farm Equestrian Centre will not available to attend or assist on the cross country & hacking facility unless the rider is receiving formal instruction. Therefore, all those using this facility who wish to school or exercise their horses/ponies do so entirely at their own risk. We have taken all reasonable precautions to ensure the safety of horses, riders and any spectators – please ensure you also take all reasonable steps to avoid and prevent accidents.
- 4) Neither the proprietor of Riding Farm Equestrian Centre nor any person acting on her behalf accepts liability for any loss, accident, injury or damage to horses, rider, spectators or any other persons or property whatsoever, and howsoever caused.
- 5) Riding hats with the following safety standards BSI kite marked PAS 015(1998 or 2011) or VG1 01.040 (2014-12). SEI marked ASTM-F1163 (2004a or 04a onwards). E2001 SNELL marked SNELL E2001 or E2016. SAI Global Mark AS/NZS 3838 (2006 onwards) **must be worn at all times** when mounted, with the chinstrap securely fastened.
- 6) Body protectors to current BETA recommendation must be worn when using the cross country course or hacking facility.
- 7) Anyone under 16 years must be supervised by an adult at all times while using the cross country or hacking facility.
- 8) Children under 10 years of age are not permitted to use the facility.
- 9) Riders using the cross country course must be accompanied either by another rider or an adult on foot. Riders using the hacking facility over the age of 16 years do not need to be accompanied. We advise taking a mobile phone with you onto the facility.
- 10) The fences that are marked with **red** and **white** numbers are to demonstrate which way they should be jumped. You do not have to jump in numerical order but **you must always** jump with a red number on your right and a white number on your left. This is for your safety and must be strictly followed. However, if the fence is not numbered you may jump in either direction providing that you have assessed that it is safe to do so.
- 11) Riders are not to ride in any field where horses are grazing.
- 12) Please close all gates behind you.
- 13) Any damage or defects to jumps, fencing or other areas of the facility must be reported at reception, even if you did not cause the damage.
- 14) We have a strict **NO DOGS** Policy whilst the facility is being used.
- 15) Instructors who are not employed by Riding Farm Equestrian Centre are not permitted to teach at these premises.
- 16) It is a condition of using the Cross Country or hacking facility that all riders must carry their own personal Public Liability insurance, cover should be for no less than £2,000,000.
- 17) It is a requirement that this agreement is updated by the rider/parent at the start of each cross country/hacking season.
